ADED 5133 History and Philosophy of Adult Education was added as an option in the Controlled Elective section. ADED 5523 Creative Supervision Skills was moved to Controlled Electives and ADED 5xx3 Workforce Development was moved into the Required Courses for Majors. And, the subheading "Required Courses for Training" was changed to "Required Courses for Major". Finally, ESFR 5403 Educational Statistics and SFTY 5013 Alcohol and Drug Ed were removed. In the Adult and Higher Education program, we are eliminating the admission requirement of submitting a writing sample and switching to asking our students to submit a personal statement along with their graduate application.

Upon learning that the testing center would begin charging our graduate students to complete the writing sample, the faculty decided that it was in the best interests of our students to eliminate this additional cost when applying to our program.

ADED 5133 History & Phil of Adult Education is being added to the Controlled Electives to provide students with appropriate course options to better prepare them for the field. Similarly, to better prepare students for the field, ADED 5523 Creative Supervision Skills was moved to Controlled Electives, ADED 5xx3 Workforce Development was moved to Required Courses for Major, ESFR 5403 Ed Stats was removed, and SFTY 5013 Alcohol & Drug Ed was removed. The subheading "Required Courses for Training" was changed to "Required Courses for Major"

for clarity and uniformity of major degree sheets in the program.
